

(DRAFT) MINUTES FROM A MEETING (Public Included) OF TRUST TAIRĀWHITI

The Tairāwhiti Voyaging Trust presented an update on their programme, Building Future Leaders and Guardians of our Moana, outlining the outcomes achieved through the FY22-FY25 partnership with Trust Tairāwhiti and their direction for the next phase of development.

They reported substantial progress over the past four years, including organisational strengthening, expanded community participation, and deeper national collaboration. More than 1,900 people have engaged in national voyages and associated on-water and in-port activities, supported by structured pathways for kaumoana, kaihautū, volunteers, and rangatahi that foster capability-building and intergenerational learning grounded in mātauranga Māori.

Operational capability has also matured, with increased crew proficiency, a stable core team, and closer alignment with the Te Hau Kōmaru waka hourua network.

Trust Tairāwhiti's investment has unlocked over \$800,000 in additional external funding, broadening the kaupapa's reach and long-term sustainability.

Trustees acknowledged the programme's strong contribution to regional identity, leadership, and wellbeing, and discussed opportunities to deepen partnerships with schools and social agencies to further strengthen rangatahi participation. Tā Derek Lardelli acknowledged the kaupapa as a vessel of cultural excellence, intergenerational learning, and identity restoration.

The Chair thanked TVT for their presentation and commended the measurable and enduring community impact of their mahi.

2.7 Board Updates

2.7.a CEO quarterly report July - September 2025 was received and noted.

The report noted that the Wellbeing Survey was scheduled to go live on 17 October, supported by a series of planned community engagements. The CEO advised that uptake had been strong, with more than 900 responses received to date and a significant presence at the A&P Show. The insights generated from the survey will play an important role in shaping future advocacy and strategic direction.

The Marae Solar Project is progressing well, with solar installations now complete across all participating marae and handovers underway. Workshops and learning support are being delivered to build confidence in system use and to increase understanding of distributed energy opportunities.

The project team is also capturing lessons learned to inform a potential "Marae Solar 2.0" and exploring monitoring tools to help marae optimise system performance.

A report on the economic potential of irrigation has been received, with a key insights summary being prepared for publication.

Work has commenced on the Construction and Demolition Waste Diversion Feasibility Study, following a successful funding application. The study is examining proven approaches in other regions and identifying practical local solutions to reduce the volume of construction waste sent to landfill, with Trust Tairāwhiti continuing to provide governance and oversight.

Business development activity remained high, with 127 enterprises supported through the Regional Business Partner network and strong uptake of Aroha Al workshops, which engaged more than 150 participants across the region.

Tourism and place-based initiatives also progressed well, particularly the City Centre Catalyst Projects, which focused on frontage improvements, activation of vacant spaces, and strengthened collaboration with Gisborne District Council and Gisborne Holdings Ltd.

Trustees discussed how wellbeing data can strengthen regional advocacy and noted the importance of measuring both qualitative and quantitative business impacts. The Board acknowledged national recognition of the Wellbeing Survey and commended staff for their work in community engagement and data sovereignty protection.
